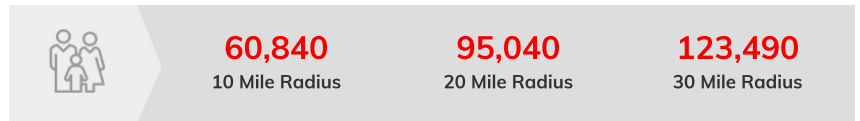


Property and Area Description

Owned by the Grand Island Area Economic Development Corp. (GIAEDC) this park has both platted and unplatted property, allowing for customized projects. The park has been declared blighted and substandard, allowing for TIF. City infrastructure such as water, sewer, electricity, and a newly paved road are available onsite. Natural gas is also available on site. Rail lines, serviced by Union Pacific Railroad, are adjacent to the site allowing for rail expansion and utilization. The GIAEDC welcomes negotiation of land purchase and lease price and utility tap fees in order to expand and develop PVIPE.

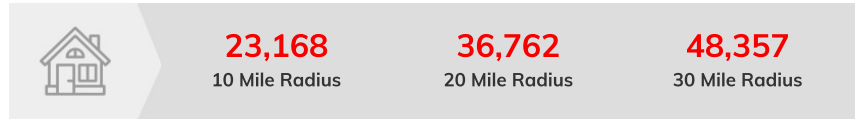
